<ul style="list-style-type: none"> • Civil status documents include the family register, birth certificate, certificate of origin, marriage certificate, divorce decree with certificate of legal force, etc. Important: The parents' names must be noted • In the case of subletting, written confirmation from the property management/owner is required. • When registering underage children, a declaration of consent from the other parent must be brought along. • When moving to Switzerland from abroad, proof of Swiss health insurance or exemption from compulsory health insurance in Switzerland must be provided within 90 days of moving to Switzerland. • Changes of residence / relocations within Allschwil must also be reported to us within two weeks of the event.
